# **D2** Channel Bank Production To Begin At MVW In '69

## **Dedication To Be Televised**

The dedication of Western Electric's Corporate Education Center on June 10 will highlight observances of the company's centennial year, which began on January 1.

The ceremonies will be beamed live to major WE locations over closed circuit television. Later, a time capsule fashioned from an undersea repeater will be buried on the Center's site, near Princeton, N.J. The capsule will contain a TV tape of the ceremonies, tapes of talks on the latest WE products, and items of historical interest.

The company plans to take note of its "Century of Progress"—the centennial theme—through various communications media throughout the entire year. Initial production of a new Bell System transmission system known as D2 Channel Bank will get underway at the Merrimack Valley Works during 1969.

The D2 Channel Bank is designed to combine and convert as many as ninety-six signals into four separate "messages," transmit them a distance up to 500 miles, then

reconvert them into separate messages. The D2 Channel Bank will add to the existing T-Carrier products currently being manufactured at the Merrimack Valley

Works, such as the D1 Channel Bank and T1 Repeater.

Whereas the D1 Channel Bank is intended for short distance or telephone exchange use, the D2 Channel Bank will provide long distance or toll use capacity.

The D2 Channel Bank will enable the operating telephone companies to eventually transmit over 8,000 simultaneous conversations over coaxial wire.

The Integrated Bay Shop, Department 1163, is currently assembling and wiring the first of the bays which will house the electronic circuitry for the first D2 Channel Bank.

But then came the fateful February 9, and with it came a howling, snow-furied





## Mass. Changes Auto Licenses

Massachusetts is about to change to the new four-year photo license statute which requires applicants to appear in person for an eye test and a photograph, according to Registrar Richard E. McLaughlin. To facilitate the new law, all Registry branch offices and the main office in Boston will be open on Monday nights until 8 o'clock, beginning on Monday, March 3.

#### **Renewal Procedure**

Renewal licenses will be issued as follows:

A form will be sent to each licensee by mail from the Registry of Motor Vehicles prior to the expiration date of the present license. The fee will be noted on the renewal application form. The form must be filled out with all questions answered and signed in ink by the applicant, who must then take it in person to a Registry office. An examiner will inspect the application and if it is in order, he will conduct an eye test. If the applicant passes the eye test, the examiner will process the form. The applicant's photo then will be taken and will appear on the license which will be presented to him on the spot. The whole renewal process will require about five minutes at the Registry counter.

## Did You Know That . .

As we increase the miniaturization of our products, we also increase the value of our apparatus and equipment vastly. For instance, a tray of electron tubes in the not so distant past may have been worth about \$150. Today, however, a tray of transistors or diodes could be worth about \$15,000.

This emphasizes an important matter: we must be very careful that we treat these items with extra care to avoid substantial dollar loss in damage or actual loss of the miniature components. A transistor, worth about \$3, can very easily be dropped to the floor and be lost, as can tiny diodes or other very small items. Needless to say, such delicate components also can be easily damaged. Please use care, and help us to reduce our costs.
